Mission Statement, Vision, Values

The Mission of The General Services Board of Alcoholics Anonymous of Ireland CLG is: To support, enhance and develop the efficient operations of the Fellowship of AA on the island of Ireland to ensure that the still suffering alcoholic will be supported to become involved in AA and receive the help they need'. The document 'Terms of reference' supports this mission statement very clearly.

Vision

"Alcoholics Anonymous is a fellowship of men and women who share their experience, strength and hope with each other that they may solve their common problem and help others to recover from alcoholism.

The only requirement for membership is a desire to stop drinking. There are no dues or fees for A.A. membership; we are self-supporting through our own contributions. A.A. is not allied with any sect, denomination, politics, organisation or institution; does not wish to engage in any controversy, neither endorses nor opposes any causes.

Our primary purpose is to stay sober and help other alcoholics to achieve sobriety."

Alcoholics Anonymous is a Twelve Step Fellowship dedicated to helping one another. The Twelve Step programme is AA's suggested programme for recovery from alcoholism and its effects.

AA's Twelve Steps are a group of principles, spiritual in their nature, which, if practiced as a way of life, can relieve the obsession to drink and enable the sufferer to become an active participating member of his/her family and society as a whole.

AA's Twelve Traditions apply to the life of the Fellowship itself. They outline the means by which AA maintains its unity and relates itself to the world about it, the way it lives and grows.

There are approximately 500 AA Groups in Ireland with an estimated 13,000 – 15,000 AA members and meetings held each week nationwide.

Introduction from our Chairperson – Cindy O'Shea

Welcome to General Service Board of Alcoholics Anonymous of Ireland CLG Annual Report for 2021, in which we round up the activities of the past year. In reviewing this period I am very proud of the way the Board has managed to continue its work and the way the office team have continued to offer the excellent service it has always delivered despite the challenging circumstances, This year's Annual Report has a new look and format, which we hope will give you an insight into the range of activities carried out and give a more professional summary of and insight into our work during 2021.

When the coronavirus pandemic hit, the impact on both the Fellowship and on the General Service Office staff as well as the Board was immediate. We urgently needed to transition our work from an in-person service to an online short-term response and adapt the office work to adhere to all public health guidelines. The General Service Office staff team have worked tirelessly to ensure that business carried on at the same professional level as always and the Board would like to acknowledge the work of the staff team over this period of time.

The Board continued to meet and through the dedication of our trustees, for whom we secured key worker status, we were able to keep our work on track throughout the lock downs and respond to the increased number of challenges presented to us as a result of the pandemic crises. I would like to acknowledge the time and commitment of each member of the board, who grappled with new technology, the vagaries of zoom and the need to travel when it was possible despite numerous challenges. We welcomed three new members to the Board this year - Aisling Hussey (Non-AA member Director), Emmet O'Hanlon as Director/AA Trustee for Leinster and Rory Hannon as Director/AA Trustee for Connaught. Brian Fitzpatrick will step down soon as Director/AA Trustee for Ulster and we would like to thank him for his work. A big welcome to Seamus Boylan, as he begins his term as Director/AA Trustee for Ulster. The generosity of spirit and willingness to get stuck in was really admirable and I would like to thank each one for their work.

One of the key challenges during the year was the impact on our finances due to the absence of in person meetings. Thanks to the generous support of the fellowship throughout the year we have weathered the storm and finish the year in good financial health, which you will see in the audited accounts. While the Board run the office on behalf of the fellowship, we could not continue to deliver the service without your support, so this is really appreciated.

Another major challenge faced by GSBAA was the huge increase in the number of calls from people in crises and needing support, while this was a regrettable aspect of Covid 19, it gave us the opportunity to design and develop a pilot project whereby we developed a phone support response service which is delivered by a panel of AA members on behalf of the GSBAA. This has been a huge success and we have been able to ensure people were either helped directly or signposted to relevant agencies for support. You will see a breakdown of the service included in the Annual Report.

We will continue to review and monitor the service and develop it is as needed.

More than anything, this year has highlighted the importance of human connection. We were able to travel to three of the four provinces/intergroups and meet Conference delegates and Intergroup Secretaries, who gave us great insight into some of the challenges on the ground as well as giving us an opportunity to build relationships and establish better communication between us. Unfortunately, due to the Omicron variant we had to delay meeting our Munster colleagues, but this will happen soon at the annual Convention planned for Munster in April. We would also like to compliment Connaught on a well-run and innovative Convention run in 2021 and the very first convention run completely online. Thanks to the Connaught team for an amazing job and very successful convention which gave several hundred people the opportunity to be present and to connect with others around the country and further afield.

As I write this report it looks likely things are a bit more hopeful, I hope that easing of coronavirus restrictions will mean we can get back to focusing on the core work of the organisation. But I also hope that we will have the opportunity to reflect on the positive learnings from the past two years and ensure we continue to be there to support the fellowship in a relevant way. To reach everyone who needs us, we must reflect the communities that we're part of and ensure we are continuing to help the fellowship to meet the need of the still suffering alcoholic. I look forward to continuing to contribute to the work of the Board and to work with you all in the coming year. It has been an interesting year and I will finish my role as Chair at next month's AGM. I would like to thank you all for the privilege of working with you and for your support and generosity.



Structure of Alcoholics Anonymous of Ireland


STRUCTURE OF ALCOHOLICS ANONYMOUS IN IRELAND



Highlights for 2021

Celebrating 75 Years of AA in Ireland

With the continuing challenges of Covid-19, the GSBAA decided to hold an online Zoom meeting to mark the anniversary of AA being 75 years in Ireland. We had speakers from each of the four provinces sharing their experience strength and hope, combined with many interesting history details about how AA came to be in Ireland. While many groups had arranged their own celebrations to mark the occasion more than 740 visitors popped in to join the occasion.



The Roadback & News Sheet

This year we combined the News Sheet into the Roadback so that our members could have all of the latest information in one publication. We changed the frequency to quarterly to allow us to spend a little more time putting each edition together. In last winter's publication, we changed the theme to be a special 75th Anniversary Edition. We included a history of AA in Ireland, a timeline of notable dates, along with readers stories and much. We also took the opportunity to include reports from September's conference meeting, along with all of the recommendations that were agreed.

Media & Public Information

We continue to respond to all requests from the media for interviews, whether it be in print, television or radio. Additionally this year we have cooperated with our national broadcaster providing props and set help for one of their soaps along with a mini drama series which has recently aired on national TV. We have completed many radio interviews on national and local stations, along with many newspaper interviews. We plan to focus a lot more on National PI this year as we acknowledge that a lot more people will be seeking our services.

Social Media


Early in 2021, as a pilot project, we developed a twitter account which went live in the springtime. We tweeted current and useful information regularly to our followers. It is envisioned that this will continue into the future, in the capacity of us pushing information and tweets, rather than an interactive service. We will continue to evaluate other social media platforms for their suitability

General Service Office (GSO)

Throughout this year the pandemic caused considerable challenges to the operations of GSO & GSBAA. While the staff operated from home, the service to members went unhindered. All calls were answered, meeting listings continued to be updated and our website became a critical go to point for the latest HSE guidelines. Information that was provided by the HSE in relation to guidelines for AA meetings was constantly updated. The shop remained closed for physical collections, but online order processing continued without break. The shop has since opened on a part time basis but will reopen fully once HSE endorses a back to work policy.

Phone Service for members through GSO

More and more telephone calls were coming to GSO from new members looking for help with their drinking. The staff are not AA members and while they were willing to answer calls, we found there was an urgency to fill the void. We launched a pilot program, whereby when you ring GSO, you could select an option to talk to an AA member. This was then routed to an AA responder who would try to help. This has been a tremendous success, especially for new members. It has also allowed the staff in GSO to carry on with their principal duties, which in turn provides a much better service to everybody that they deal with, and gives the callers the support that helps them by talking with a fellow alcoholic. These figures are reflected in the graph below.



Finance

When our face to face meetings stopped, so too did the majority of contributions that normally flow through AA. We made a decision to make our 'Contribute' Button on our website much more accessible to all members. Thankfully this was well received and because of members contributions, we were able to operate without dipping into our prudent reserve. Of course, there were many other contributing factors, including a significant cost saving by having our Annual General Conference online. AA meetings, Board meetings, Office management meetings all continued online providing a significant cost saving to the total operating costs.

First Online All-Ireland Convention

During the year, Connaught Intergroup hosted at short notice, the very first All-Ireland Convention online. They overcame many challenges, and in a short time successfully ran an event that attracted hundreds of attendees in a way where the AA message was carried, in a safe and friendly manner.

We've been working behind the scenes to update the infrastructure and internals of our website for the past few months. We've invested in a format that will be more cost effective and much easier to maintain going forward. We hope to include many improvements to the website content, how meetings are found and the general look and feel. The shop has been completely revamped, we are putting the finishing touches to the new 'Just for Today'

section, our online 'Big Book' section along with other pamphlets in pdf format. We've removed the need to login for members, and you will be able to submit meeting information much easier. It should also be a lot more useable when using your phone or tablet. We also plan to have a region area for each intergroup.

Financial Information


2021 has been successful from a financial perspective. Contributions from the fellowship amounted to €275,023, an increase of €3,252 over 2020. Similarly, the sale of literature income has increased by €19,144 totalling €71,775. In addition, overheads have decreased as a direct result of COVID-19 and the subsequent economic impact, they continue to be monitored on an ongoing basis and maintained at present levels where possible.


