The General Service Board of AA is aware that some Groups are not properly displayed within the Google locator in the meeting section of the website.


Your Group can follow this procedure to ensure the correct location is displayed on the website.

- 1. Log onto www.itouchmap.com/latlong.html
- 2. Type in the street address and town/county for your Group.
- 3. The map will change to your Group's area location.
- Zoom in and place the red pointer at the place where your meeting is held and be as precise as possible.
- Once you have done this, scroll down the page, you will see the latitude and longitude co-ordinates displayed on the left hand side box
- 6. Email GSO with these co-ordinates along with your Group no., town and County. GSO will then amend your details on our system to show the correct location of your Group on the website.

Group Members are asked to check their meeting place location on the website and if need be, send correct co-ordinates for the Group's venue to GSO.

FIRST ARTICLE FIRST ISSUE;

Vol 1, No 1—NEWS SHEET September 1979.

A meeting of representatives of the fellowship from the four provinces of Ireland took place at the Crofton Airport Hotel, Dublin on the 24th November, 1968. The object of the meeting was to consider the setting up of a Service STRUCTURE for Ireland arising from the growing feeling that, despite the valiant and unceasing work of the early Groups and individual members and the existence of Inter Groups in the Province of varying structures and aims, the need existed for some body acting under the authority of the fellowship as a whole to be of service to the existing Groups and members and the anticipated growth. This meeting which was then called the All Ireland National Inter Group . This Committee was the first meeting of the General Service Conference. It was unanimously decided that there was a real need for a SERVICE STRUCTURE in Ireland in view of the circumstances then existing which included:

- ⇒ The difficulties experienced by Groups in getting literature, slogans etc.. Whilst the early Groups helped out when possible, they had limited resources. Individual Groups had to import literature from abroad with the constant delays and customs difficulties.
- ⇒ There was no official listings of Groups and Meetings.
- ⇒ A.A. in Ireland did not have an address or central point of contact. Internationally known, the Country Shop which was the meeting place for the first Irish Group, was a business premises by day.
- ⇒ The extent of A.A. membership was entirely unknown. Estimated figures were regularly quoted but were later shown to be too high.
- ⇒ There was no co-ordinating body of the fellowship in Ireland such as existed in almost every other country at the time.

At its first and subsequent meetings, Conference acting as the servant to the fellowship as a whole in Ireland and existing only as long as the fellowship required it, guided by and observing The Third Legacy of A.A. World Service and The Twelve Concepts of World Service as applied to Ireland decided to investigate immediately:

The feasibility of setting up a General Service Office and

Preparing and publishing an A.A. Directory of Groups and Meetings in Ireland.

Money was needed for these purposes. It was also needed to cover the expense of Conference Meetings, for the reason that no member could be excluded from being a delegate to Conference because of inability to pay travel and hotel expenses involved. Those delegates who did not wish to avail of these expenses could decline them anonymously.

After careful consideration it was decided that Conference expenses could be funded from voluntary contributions from Groups at the suggested rate of 50p per member per annum. To this day this system is operated in Groups.

When it came to financing the suggested General Service Office and the building up of a fund to meet rent, rates, literature, salaries, office expenses and furniture etc., it became clear that subscriptions from ordinary Group funds could not meet the costs involved. It was decided to appeal to individual members of the fellowship for voluntary subscriptions on an annual basis.

The appeal was directed especially to members who had been sober in A.A. for some time, who could afford to subscribe, having regard to their commitments, and who wished to show their gratitude in a tangible way for the benefits they had received from A.A. The money was forthcoming and the General Service Office opened at 26 Essex Quay, Dublin 8 in 1970.

PAYING OUR WAY 2013

Our Groups are spiritual entities, not business organisations. As such, in the spirit of the Seventh Tradition, "we are fully self supporting, declining outside contributions". Conference today and the General Service Office (GSO) are funded from Group subscriptions. The Board would like to thank the Groups for their continued support in enabling A.A. services at local, area and national level.

G.S.R.

GROUP SERVICE REPRESENATIVE

In the early years of CONFERENCE, Groups sent two G.S.R.'S to the Provincial Inter Group Meetings. This worked very well for a number of years. But with the large growth of Groups, the Intergroup meetings became too large and unwieldy. Groups and the G.S.R.'s became dis-satisfied because with the time available and the big number of delegates attending, they found it increasingly difficult to express their views of the Groups and to get understanding of the workings of Conference. So the structure of the Provincial Intergroups had to change. Instead of sending G.S.R.'s to Intergroup, the Groups send them to their Area Committee. The Area Committee could be a geographical county or a combination of 'Unity Groups' in an area as the Groups and the Intergroup would decide. The G.S.R.'s now attend the Area Committee who in turn sends delegates to the Intergroup. Each Intergroup sends four delegates , Intergroup Secretary and Trustee (from the General Service Board) to Conference..

It will be seen that the Group G.S..R. is the corner stone in the Structure. If a Group has no G.S.R.'s; they are ineffective, unavailable or non communicative both from and to the Group, then both the Group and Conference are the losers.
